I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, and Members of the Assembly are witnesses to the fact, Ann Marie Retzlaff, by her own hand and amoral actions created turmoil, confusion, falsification, deception, committed fraud upon the Wisconsin General Jural Assembly as referenced in the Statement of Facts Summary, Regarding the Actions of Ann Marie Retzlaff. Furthermore, David Lester Straight documentation confirm Ann Marie Retzlaff is Not Eligible To Be A Member or Officer of the Wisconsin General Jural Assembly.

Statement of Facts Summary, Regarding the Actions of Ann Marie Retzlaff

To: Ann Marie Retzlaff, et.al,

I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, Affiant herein am over the age of twenty-one years, and competent to make this Affidavit of my own first-hand knowledge, and do hereby declare under penalty of perjury under the laws of the United States of America that the following statements are true, correct, complete, and not intended to be misleading. Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, have not received any objections from Ann Marie Retzlaff to the following;

- A. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, in possession of documentation excludes Ann Marie Retzlaff's participation in the WI Assembly, due to her revocation of citizenship and status as a state national. Evidence: Exhibit.23.04_024b
- B. Ann Marie Retzlaff April 16 and May 21 freely stated in front of an assembly of people that she "started" the David Lester Straight's document, an instrument known as Affidavit of Truth and Assertory Oath Repudiation and Revocation of Citizenship, and "never did anything with it." She also stated at both meetings why it was wrong to do the David Lester Straight's paperwork.
- C. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, in possession of documentation, signed by Ann Marie Retzlaff, titled Affidavit of Truth and Assertory Oath Repudiation and Revocation of Citizenship, completed, signed, notarized by Deborah Leger of Union County, Georgia. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, in possession of documentation, titled Notice of Default Certified "Judgment" of Un-Rebutted Affidavit, signed by Ann Marie Retzlaff on 4/21/2022. Witnessed and notarized by Dana Ritchie of the State of Wisconsin, Document #767015 filed on 4/22/2022 with Register of Deeds Shawano WI. Exhibit.23.04_024b Refer to pages 1-3.
- E. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, in possession of 76 pages of documentation, titled Notice of Default Certified "Judgment" of Un-Rebutted Affidavit, signed by Ann Marie Retzlaff on 4/21/2022. Witnessed and notarized by Dana Ritchie of the State of Wisconsin. Document #767015 is filed on 4/22/2022 with

Register of Deeds Shawano WI at 8:19am. Evidence: Exhibit.23.04_024b, refer to pages 1 through 17.

- F. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, in possession of Ann Marie Retzlaff's "affidavit" lacking form, claims she filed paperwork to disavow the Affidavit of Truth and Assertory Oath Repudiation and Revocation of Citizenship in February 2023. Evidence: Exhibit.23.07_013, lines 142 – 146.
- G. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, in possession documentation, titled Declaration of Un-a-liable Rights held by Indigenous Power, signed by Ann Marie Retzlaff, dated 2/22/2023. This is the document referenced by Ann Marie Retzlaff as claimed to be filed disavowing her Revocation of Citizenship and her disassociation with David Lester Strait. The seal on the document is not legible and no reference of authorized use can be witnessed. References to case numbers are noted in the document. Evidence: Exhibit.23.08_001. Refer to pages 2 – 4.
- H. This document mentioned above was never filed with Shawano County Clerk, Clerk of Court, Register of Deeds. Nor was the document filed with any court cases listed in the document. Evidence: Exhibit.23.08_0001. Refer to page 1.
 - a. Page 1, document dated 2/22/2023 was never filed with Shawano County Clerk, Clerk of Court, Register of Deeds.
- I. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, in possession documentation, from Larenda Maulson, Corporation Counsel, Shawano County about the document mentioned in item G and H. Ms. Maulson writes; "that this document was never presented to Shawano County prior to July 18, 2023" until presented by Michael M. in person to Shawano County Corporate Counsel. "The document has not been filed in the Register of Deeds office, nor has it been filed with the Clerk of Court in the court cases listed on the document. Further, the County itself does not have a seal similar to the seal on page 3 of the enclosed documentation." **The stamp "Received" on the first page is dated and shows "SHAWANO COUNTY CLERK"**. Evidence: Exhibit.23.08_0001.
- J. Any Publishing Notice relating to Shawano County being settled involving Ann Marie Retzlaff in any, shape or form are not accurate and are invalid. Settlement claims have been posted in The Shawano Leader on August 4th, August 11th and August 18th, 2023. Published notice for Shawano County settlement is not a county settlement document in its true form. Furthermore, on June 18, 2023 Ann Marie Retzlaff's title was removed as moderator and expelled from the Assembly, therefore Ann Marie Retzlaff has no standing to publishing such a Notice, thereby Notice is invalid. I, Andrée Michéle Ringwald on behalf of the Wisconsin General Jural Assembly, and Members of the Assembly are witnesses to multiple lies, deceit, lack of personal responsibility, avoidance of personal consequences, and the shifting blame to others by Ann Marie Retzlaff. These character flaws without corrections by Ann Marie Retzlaff alone are reason for expulsion from the Wisconsin Assembly including slanderous and foul language to Assembly members and non-Assembly people in numerous emails, meetings, and other types of correspondence.

Through her current words, actions, activities and correspondence, Ann Marie Retzlaff's actions unbecoming has defamed, harmed and put the Wisconsin General Jural Assembly at risk; Therefore, let it be known, Ann Marie Retzlaff due to her words and actions of her own free will and concurrence, was expelled from the Wisconsin Assembly on June 18, 2023.
