## \*\*\*NOTICE TO ALL AMERICAN VETERANS\*\*\*

To: All American Veterans of The Armed Forces of the United States

From: Our United Republic and The American People's Public Trust

In Refer: Recording DD214, Upgrade Review Hearing, and Veteran Name and SSN/SN

#### **Purpose of Correspondence**

When the Veteran was discharged, they were provided a DD214, but the process of returning to "HOME OF RECORD" was not completed. Technically, by International Law, ALL Living Veterans are Missing in Action on return from overseas to the Home of Record or Prisoners of the War of 1812. This situation was specifically politically suppressed by Individuals in NATO, EU, US Congress, Federal Gov, and Various Nefarious Private Sector Organizations to purposely exploit the Veterans and The American People to make sure evil and corruption reigned by ceding power and wealth to the unworthy few at the cost of the American Nation.

At this time, the ONLY Veterans who have been returned to Home of Record were in a casket escorted by Military Personnel or those with funeral ceremonies under military honor.

#### **Initial Process for Return**

These are the initial steps necessary to Prepare for the Veteran's Official Return to Home of Record and Public Sector Emancipation.

#### 1. Record Original DD214 to Land Record.

- 1.1. The Veteran needs to physically take their Original DD214 down to the local Court House where the Land Records are Recorded and have their DD214 Recorded. There may be a small cost. The staff will know what to do if you are in the right place.
  - 1.1.1. After recording, have 5 Certified Copies made which will also cost a small fee. Hold onto them until you receive further instructions.
- 2. NOTICE to Veteran: As the American Republic comes back online. Please be aware this will reactivate domestic common defence duties and responsibilities as an American National Guardian under the honorable conditions of an American

Militiamen. That honorable status will be subject to review and, if necessary, proper removal.

3. Remember: With Great Power comes responsibility if you want to be treated with respect and honor instead of the General Public. Maintain your behavior and be accountable for your actions. Many in our nation are going to be looking for the Veterans to step up and help lead them out of this despotism. If you can't or won't act accordingly, please do not go through this process. Remain where you are.

#### 4. Veteran Discharge Upgrade or Review

- 4.1. All American Veterans are required to get a discharge review no matter what type of discharge. The review is at Special Equity law, which is a National Jurisdiction, and provides a Court Order making the Veteran an American Individual of Protected Class in the Private Sector. The Court will also provide a new DD214 with a Red United States Seal at the Bottom.
- 4.2. The Review moves the Veteran from their Overseas Jurisdiction back into National Jurisdiction, which is currently blocked by the US Congress and Federal Gov.
- 4.3. This process is for ALL Veterans with Honorable, General under Honorable, and General Discharges. This process is NOT for other than honorable or bad conduct discharges.

  - 4.3.2. If you are advised that you do not need a review because your discharge is honorable, just tell them you would like to have the review to confirm by court order your discharge status. Most likely, the VA Representative will Not understand or have not been educated on this process.

# 5. Physical Copy of Veteran Personnel File, Veteran Name, and SSN/SN from National Archives

- 5.1. https://www.archives.gov/
  - 5.1.1. In Request: Specifically Request the Veteran Service Number be Provided.
    - 5.1.1.1. When they respond, there will be an authentication letter stating the "Veteran's Name" which is the American National Name.
    - 5.1.1.2. The Letter will also Include a statement that the Veteran uses their Social Security Number as a Service Number or SSN/SN.
      - 5.1.1.2.1. This is what will be used to convey the administrative authority for the Veteran Social Security Trust back to the National Judge Advocates or their Authorized and Registered Administrative

Organizations and away from the US Congress, Fed GOVT, State GOVT, and Local Civil Courts making the Veteran foreign American National Individual no longer a US Citizen.

- 6. Currently Active Military or Individuals entering Military Service.
  - 6.1. **Currently active:** Advise them to contact the JAG office and request a copy of the Fed Birth Certificate and any other Birth Certificates available if they are comfortable.
  - 6.2. **Entering Service:** Advise them to pay attention when they go for the Legal Name Change, which will most likely be in basic training when they do a personnel file review. Advise them to change something in their name in some way.
    - 6.2.1. President Dwight D. Eisenhower was born David Dwight Eisenhower in his family bible.
    - 6.2.2. Suggest reversing the middle name and first name or advise them to put a letter at the front of their name (L Ron Hubbard), maybe an identifier like the Second or Senior.
