exercise our right to peaceful assembly to study our original founding documents bringing us into statehood in 1848, to develop, petition, and protest our abuses of government and bring remedy and recourse, peacefully, to our sovereign people.

We are a group of people who have come together to bring America back to what it was originally intended to be, under Common Law, by the people and for the people, not big corporations and special interests. We are actively seeking people who are willing to step forward and help take back what is lawfully ours.

### WHAT IS A GENERAL JURAL ASSEMBLY?

We are a group of citizens coming together, as an independent body operating under the constitution with jurisdiction in both Common Law and Statutory Law. We have lawful authority over all government to address constitutional usurpations through decrees and invoking our unalienable rights!

### WHAT IS COMMON LAW?

It is the governance originally created by the Constitution, where power rests with the people. The simplest explanation of Common Law is that if there is no injured party, there is no crime. Some highlights of living under Common Law are:

- No income tax
- No property tax
- Right to keep and bear arms
- Local farms & businesses
- Government limited to 19 essential services.

### HOW WILL WE ACCOMPLISH THIS?

By assembling 13 people in 29 counties in Wisconsin, we will be able to make a declaration via public notice that we are standing our state.

This will enable us to:

- Restore state government back to de jure form of government
- Protect the people from government abuse
- Investigate matters that affect the people and redress grievances
- Call a Grand Jury & ensure bad actors are brought to justice

### BACKGROUND HISTORY

**1783**, America became a country, and each state was a separate Republic, united by a small, central government.

**1861** Abraham Lincoln, an attorney, became President in violation of the 13th Amendment (the Title of Nobilities Act) and eleven southern states walked out of congress without adjourning and setting a date to return. In Latin, this is called Sine Die and doing so declared the Republican form of Constitutional government vacant. Since this date and declaration of vacancy, America had no government and all government actions are “defacto” and fraud.

**1871**, with a massive debt due to the Civil War, America declared bankruptcy and was sold to investors and a privately-owned corporation took its place. Washington, DC was created as a foreign country/corporation, and Congress returned but was now working for the corporation.

**1928** the War Department issued Field Manual 2000-25 on Citizenship and how to return to a Republican form of Constitutional government.

**1945** Gen. Douglas MacArthur trained a handful of Special Forces in nation-building and the Constitution, who then formed the “Restore America Plan”.

**2009** Those who studied under MacArthur and Restore America initiated the resettling of counties and states via original jurisdiction assemblies. The Michigan General Jural Assembly (MGJA) adjourned the Congress Sine Die 1861 session, brought forward to 2010, and gave POTUS and the Michigan Governor notice which is un rebutted and recognized presently as the true government. This assembly has issued 21 Requisitions to POTUS, Joint Chiefs of Staff, Pentagon and Secretary of State, in effect today.

Wisconsin is working to replicate this model, to bring our state back to deJure status, for the people. We only need 13 people in --- counties to accomplish this!
